1. Introduction

- 1.1 These Terms of Use apply to:
 - (a) the website at [https://eymillionyou-collaboration.com/] and its subdomains (the "**Website**") and your use of the Website;
 - (b) the online discussion forums, facilities and functionality that are made available or delivered via the Website whether delivered through the Website or an API (Application Program Interface), including but not limited to software as a service and hosted software, including Restricted Functions (defined in Section 3.2 below) (together, "Online Forums"); and
 - (c) all content (including but not limited to text, data, video, sound recordings, graphics, photographs, applications, tools and functionality) published on the Website and/or Online Forums by EYG or made available by EYG through the Website and/or Online Forums ("EY Materials").
 - 1.2 These Terms of Use govern the Website, Online Forums and EY Materials.
 - 1.3 By accessing the Website and/or by using the Online Forums and/or EY Materials, you are agreeing to be bound by these Terms of Use.
 - 1.4 "EYG" refers to EYGS LLP, a limited liability partnership incorporated in England with registered number OC301032. EYGS LLP does not provide services to clients.

"EY Firm" means a member of the global network of EY firms, each of which is a separate legal entity.

- "EY Persons" means any member, shareholder, director, officer, partner, principal or employee of any EY Firm and "EY Persons" shall be construed accordingly.
- 1.5 In these Terms of Use, the word "including" should be read to mean "including but not limited to".
- 1.6 The privacy notice explains the information that EYG collects about users of the Website, Online Forums and EY Materials, and how EYG uses that information.

4. Intellectual property

5. Your use of the Website and the Online Forums

5.1 Subject to your compliance with these Terms of Use, EYG grants you a non-exclusive, nontransferable, revocable license to access the Website and the EY Materials and to post content on the Online Forums strictly in accordance with these Terms of Use.

5.2 You shall not:

- 6.5 EYG will be moderating the content posted on the Online Forums. EYG reserves the right to remove, disable access to or edit Your Content without notice at any time for any reason.
- 6.6 You indemnify and hold harmless EYG, the EY Firms and all EY Persons on a continuing basis against all claims, legal proceedings, losses, damages, costs (including but not limited to legal costs on a full indemnity basis), expenses penalties and fines that any of them suffer or incur as a result of:
 - (a) any claim or claims by any third party that use of Your Content in accordance with Section
 6.2 infringes the intellectual property rights or any other rights of any person; and/or constitutes a breach of confidence; and
 - (b) any breach by you of Section 6.4.

7. Links to third party sites and content

- 7.1 From time to time, the Website and Online Forums may include links or access to third party websites or services. Such links and access are provided for your convenience only and do not signify that EYG endorses such third-party websites or services. EYG does not review such third-party websites or services. Accordingly, you acknowledge and agree that:
 - (a) EYG is not responsible for such websites or services, including but not limited to the terms on which they are made available and their privacy policies, and EYG does not control or have any responsibility for their content, functionality or availability;
 - (b) EYG makes no representation, warranty or condition, either express or implied, in relation to any goods or services or information received from such websites or services; and

(c) if you access any such websites or services, you do so entirely at your own risk.

8. Changes to Terms of Use

- 8.1 EYG may amend these Terms of Use at any time. EYG will publish amendments to these Terms of Use on the Website and will inform you about any changes through the Website.
- 8.2 If EYG amends these Terms of Use, the amendments will take effect from the effective date of the change published on the Website. The date on which this Terms of Use was last updated or amended is shown at the top of this Terms of Use. By continuing to access or use the Website, Online Forums or EY Materials after the date on which the amended Terms of Use are effective, you are confirming your acceptance of the amended Terms of Use. If you do not agree to the amended Terms of Use, you must immediately stop using the Website, the Online Forums and EY Materials.
- 8.3 EYG may make changes to the Website and/or Online Forums and/or EY Materials for any reason at any time without providing notice to you.

9. Termination

10. Third party rights

Provisions that by their nature may benefit the EY Firms or the EY Persons are intended to be for their benefit and they shall be entitled to rely upon and enforce those provisions. Otherwise, a person who is not a party to this Terms of Use may not rely upon or enforce any terms of these Terms and Conditions and shall have no third-party rights under these Terms of Use.

11. Sole Recourse

Your recourse with respect to any matter arising under these Terms of Use (including any obligation of EYG) shall be limited to the assets of EYG and you shall have no recourse against and shall bring no claim against any EY Firm or EY Person.

12. Other

- 12.1 Illegality/Severability: If any provision of these Terms of Use is declared by any competent court or body to be illegal, invalid or unenforceable under the law of any jurisdiction, or if any enactment is passed that renders any provision illegal, invalid or unenforceable under the law of any jurisdiction, it shall be deemed severed from these Terms of Use to the minimum extent required by such jurisdiction and this shall not affect or impair the legality, validity or enforceability of the remaining provisions.
- 12.2 Waiver: If EYG fails to insist that you meet your obligations under these Terms of Use or if EYG does not enforce its rights against you or if EYG delays in doing so, that will not mean that EYG has waived its rights against you and it does not mean that you do not have to comply with those obligations. If EYG does waive a default by you, EYG will only do so in writing and that will not

- mean that EYG will automatically waive any later default by you. Even if EYG delays in enforcing its rights under these Terms of Use, EYG may still enforce its rights later.
